REPORT FROM WARD MEMBER, COUNCILLOR SUE JONES

I hope you have all had a good Christmas and wish you all the best for 2023. During December there have been many celebrations and Christmas parties for the children by The Con. Club, the Mickey Mouse Club, The Commercial Pub and Gowerton RFC and Santa in attendance at all of them. Father Christmas visit with the horse and trap organised by The Community Council which also ended with a visit to The Commercial by the Big Man organised by Dean, Lyneth, Kaylie and Phil. Chocolates were provided for the children by Community Council. (Left over chocolates were given to the residents of Dan yr Alt and Llys Elba).

The residents of Dan y Alt were entertained by the children of the Primary School and thanks to Mr Ashton and Mrs Hughes for their support. I also attended an Elderly Care home during the build up to Christmas and had an enjoyable afternoon joining the carol singing.

The Charity Event organised by Mrs Joan Lewis MBE in the Con Club was a great success and it was announced that she had reached a Million Pounds fund raising for the equipment used in the treatment of Cancer in Swansea, Neath and Port Talbot. Congratulations and well done to her.

It is good to see the new warning signs for height restrictions at the Doctors Surgery side of the Railway bridge which hopefully will prevent some of the accidents in that area.

Gowerton Library is providing a warm place for residents who are finding difficulty in heating their homes. I will give further information when other places have been identified.

Summit Good based between Dunvant, Gowerton and Waunarlwydd have been supported by Swansea University to plant approx. 1,000 trees at this location.

I am sorry to see that a glass panel has been vandalised in the Library during the Christmas period and hopefully the CCTV camera will identify the culprit. Such mindless vandalism is so very sad.

During December the Churches and Chapels of Waunarlwydd and Gowerton collected and distributed hampers for many vulnerable families of our area. I would like to thank the people who contributed and the members who put the hampers together. The excess items were given to the Co Op for the food bank collection basket.

I attended the Freedom of the City Ceremonial Service at the Guildhall for Kevin John MBE. It is so well deserved and congratulations to him on this achievement. I also attended various other meetings in the Guildhall.

I attended a meeting with Councillor Jenkins, and a resident who had been flooded during the month of November, and am awaiting an update. I have contacted Welsh Water on the flooding issue on Sterry Road and am waiting for an update, this in conjunction with a resident of Sterry Road who has also been flooded.

The new development at the end of Fairwood Terrace has now been advertised and there is a lot of concern regarding this development. The infrastructure of Gowerton needs upgrading to accommodate any further building in our village. The egress and access into Fairwood Terrace for any additional traffic and the knock-on affect of flooding in the area is a great concern. Perhaps we could call for a public meeting to address some of the concerns regarding this development.

REPORT FROM WARD MEMBER, COUNCILLOR DAI JENKINS

Cllr Dai Jenkins Monthly Report 5th December 2022 to 3rd January 2023

Liaising with Apple Trees Fruit Trees Nursery arranging collection of fruit trees to plant in January 2023. Give Way Sign George Manning Way, quoted a cost, Cllr Sue Jones informed me that cost may be able to come off Highways budget not ours so have emailed Highways Officers querying that prospect. Two email sent to Swansea City Council highlighting concerns of Bryn Y Mor Road and Sterry Road flooding, many issues, so it's on going. Asked cleansing team to clear lane by Dan Yr Allt.

New proposed developments at end of Fairwood Terrace, constructed email to be sent before 12.1.23, shared initially with Community Council and Cllr Sue Jones as we are working together on many questions and issues regarding the new development. Missing link on B4295 where Bryn Y Mor Road becomes Penclawdd Road, liaising and working with Active Travel; and Cllrs Sue Jones and Cllrs Andrew Williams(Penclawdd Ward) to try and complete the missing link. Ongoing. Speed Cushions in Gowerton ascertained information on when and where the original works order plan were posted in Gowerton and on line, dispatched to some residents who had specifically asked for that information and to Community Council, still awaiting a report from Highways Safety Officers on suggestions for improvements, however; I have been advised that due to new 20mph legislation due September 2023 their workload has substantially increased and that is the delay, so still on going.

New Bus stop and shelter outside Launderette Gorwydd Rd, spoke with owner of Launderette and email advice given. Liaised with resident on Cecil Road regards flooding issues, email advice given. Cycling UK Advocate contacted me regards lighting on pathway running through Gowerton towards Blackpill, query asked and answered, not available due to funding, wildlife & maintenance. Speeding of cyclists between Gowerton and Dunvant, survey found little evidence of any bikes going faster than 18 mph, so no further action required., Two new bins George Manning Way and Gorwydd Rd (next

to Bishwell Rd) – Before I became a Councillor reported unsafe tree behind a house in Bishwell Rd, followed up and chased successfully when I became elected that's now been felled, much to the delight of resident concerned.

D Council Tax Base/Precept Requirement for next financial year

Members are aware that properties are to be banded from "A" to "I" and that any precept raised by Council has a direct bearing on the Council Tax borne by residents. The current Council Tax Base for Gowerton has been calculated by the City and County of Swansea Finance Department at 1966 which is a decrease of 26 Band D dwellings since last year. The method of calculating Council Tax per property is by formula.

Last year's precept remained the same as the previous years due to the tight financial restraints on City and County of Swansea's budgets.

E Summary and Recommendation

To repeat the existing precept for the next financial year is a viable option and in the current financial climate, it would need to be seriously considered. We have reserves to cover any shortfall that might occur by not increasing the precept amount.

I do not recommend cutting the precept at this time.

It is necessary to inform the Director of Finance of the precept requirement by 31 January 2021.

85. QUESTIONS RELATIVE TO COUNCIL BUSINESS

- 1. We were sad to receive the resignation of Cllr Ann Guard. Ann has been a long serving member of Community Council and has been very pro active during her service. We would like to send Ann our very best wishes and she will be very much missed, though we hope she will still send in any news or information as she is very active around the village.
- 2. Cllr Brian Edy said the footpaths between Bryn y Mor Road and Ballard Estate are full of leaves. This is the responsibility of Compton Estate.
- 3. Cllr Edy mentioned the Solar farm developments screening report sent around. Welsh Government can see very little environmental impact and no reason for it not to go ahead. Cllr Edy will contact Gorseinon Council to ask about a public meeting.
- 4. Cllr Pat Evans organized a litter pick with the staff and pupils of Ysgol Gyfyn Gwyr which was very successful. The next one will be organised due to where the most littered places are. Maybe litter pick in the woods in the summer?
- 5. Cllr Amanda Guard brought up the number of dogs off lead in the Elba. Unfornately, there is not much we can do about this. Freedom leisure do not allow anyone to put up signs or posters about dogs being on leads or picking up after dogs. Also, there would not be any one to monitor this. We can only appeal to the better nature of dog owners to be mindful that children play sport on the pitches and to use the areas around the pitches to exercise their dogs.
- 6. Cllr Barbara Small mentioned the subject of the large bill pending from Audit Wales from the audit carried out in 2018/19 when the previous Clerk was in post. Clerk to contact Lyn Llewellyn to ask why it was not picked up during internal audit?
- 7. Cllr Small asked where the wooden signs by the doctors etc have gone? Cllr Jones said they are in her garage drying out. Possibly get plastic signs. Maybe pay for these from Sues community budget.
