- 41. TO RECEIVE THE REPORT OF THE WARD MEMBERS:

REPORT FROM WARD MEMBER, COUNCILLOR SUE JONES

It has again been a very busy two months on individual issues and complaints for residents, rather than meetings at the Council. Scrutiny Meeting are now in progress and the work programs are being organized. There has been a meeting of the Development and Regeneration Scrutiny when updates were given of the many projects that are being progressed for Swansea e.g. The completion of the Arena, 71 and 72 Kingsway Project, and Penderyn project. It is an exciting time for the city.

Councillor Jenkins and I had a meeting at the beginning of the Cycle Track at the bottom of the Woodlands, where we discussed the possibility of celebrating the heritage of the Gowerton South Railway Station with artwork. We are still awaiting the outcome of that meeting. This will be funded by Active Travel Fund.

The Cricket Club entertained Glamorgan Cricket Club during this time, and I organized a vintage tea for both players and spectators. Thanks to a great volunteering team, we raised money for the renovation of the Pavilion. Thanks also to The Temple who lent their crockery, and to the Co Op and volunteers for their kind donations of Coffee, Tea, Sugar and cakes. It was a successful day.

I took the Chair of Community Council. (Ros Holt) and the Clerk (Allison James) to tea in the Mansion House, where we meet the Lord Mayor and his wife (Councillor Mike Day and Christine) it was an enjoyable afternoon.

I met the Ukrainian family and presented the funds which were collected at St. John's Church Hall and some presents donated by individuals. I am organizing a Coffee Morning for the Ukraine families around this area to get together and be able to chat in their own language - look out for the publicity of this event. Hopefully this will take place in the Conservative Club on Thursday the 22nd. Of September from 10am to 12pm.

There have been a number of incidents of concern with the young people in the village e.g. youngsters on the Railway Line. Councillor Jenkins and I met with Network Rail and had discussions regarding the fencing of the area. We also meet with our Policing Team and discussed these issues which resulted in some suggestions to address our concerns. The Police joined forces with the Friends of Woodlands and Open spaces and visited Alltwen Woods. I also attended a "Teams" meeting with Inspector Simon Trick and discussed issues relevant to Gowerton.

The beginning of a new school year has commenced, and I would like to put on record my thanks to Mr. Nigel Jones for his leadership with the Comprehensive School, his interest in our Community and the pupils, and my best wishes on his retirement. Also welcome the new Headteacher Miss Kath Lawlor to her new post. Congratulations to all the students

on their exam results and thanks again for the hard work of the teachers and the pupils. The Primary School has also seen the retirement of Mrs. Debbie Roberts and I also wish her a long and healthy retirement and thanks for her leadership in the School. Mr. Iain Ashton is starting in his new role as Deputy Head, and I wish him all the best. Over the past three years both Schools have supported all the pupils through a very difficult time.

I am progressing the request for a Boules Pitch at the Elba and have agreed to fund this venture. Would Community Council be prepared to fund the maintenance for this pitch? This venture has a lot of support from the residents of the village.

During Full Council last week Councillor Robert Francis Davies gave assurances that the park in Park Road would be enhanced which I am looking forward to. There has been some vandalism there over the Summer Holidays.

I attended the funeral in St.John's Church of the former Councillor for Gowerton Mr. Ron Thomas. Mr.Thomas was 90 years of age and served Gowerton for 13 years and leaves his wife Pam. My condolences to his family.

Over the past two weeks I have been involved alongside other Council colleagues in raising funds for the Pakistan Flood victims. Hair cutting before starting back to school with coffee and cake. We raised over £400.00 on the day and are expecting more donations.

I have reported the Graffiti around the area and today (Tuesday) it has been removed from along the Woodlands and the Cycle Path. There is some graffiti on the walls alongside the Cycle Track which is the responsibility of the landowners and they will be contacted by the Authority. Thank you to the Graffiti Team???(one person for the whole Authority).

The heavy rain of Monday evening caused great problems with many of the shops on Sterry Road being flooded. I visited them and spoke to Highways regarding the drains on Sterry Road and managed to have the drain cleaning lorry visit the area. There also was a problem with flooding in one of the houses also on Sterry Rd and again I have visited this resident. Mount Street gully has been filled in which caused many problems. Highways are going to make a visit and assess the situation.

REPORT FROM WARD MEMBER, COUNCILLOR DAI JENKINS

Cllr Dai Jenkins - Monthly Report 6 July 2022 to 7 Sept 2022

1. I am dealing with the 'speed cushions', and am awaiting reports from Alan Ferris who was on leave in August 2022 and awaiting his reply to community council, before I chase and update. Cllr. Sue Jones and myself have worked jointly in meetings for the following a) Enhancing the area by Gowerton lights for possible upgrade (This will be out of the active travel budget) b) Met with pcso and Police on antic social behaviour c) Young people playing on the railway lines.d) Anti-social behaviour in new coastal site at George Manning Way. I am organising a Dog Show behind the commercial on Sunday 25th September 2022 at 2pm, it's a free community event. Attend Rechabite hall 2.9.22 for walk in session with Gower MP Tonia Antoniazzi.

I have been contacted by residents and I am dealing or have dealt with the following ~

- 1.The dip between Gorwydd Road and Woodland officer has advised may take a few more months to complete and supplied me with link to what council will and will not cut back ongoing.
- 2. Woodland Terrace itself, residents can't park their cars properly due to overhanging branches reported those. Annual leave issues, will monitor..
- 3. Overhanging branches on footpath B4295 opposite Tescos- reported same, branches causing issues on the other side of the fence into Llys Baldwin. attended site 5.9.22 as officer advised been actioned, its not, photographs taken and sent to officer accordingly. Ongoing
- 4. On site visit with Cllr Sue Jones and Alan Ferris to discuss Pelican Crossing over Victoria Road, ongoing with ballpark figure of 60K. Alan to get back to us. No update off Alan due to a spell of annual leave.
- 5. Request for a roundabout at junction of Bishwell Road, working on a fuller solution, which will incorporate a left turn only out of new Gorwydd Colliery estate again in consultation with residents who are involved the most. Awaiting approval of my letter to residence. Ongoing. ..
- 6. Waunarlwydd resident who uses Gowerton thoroughfare reported left turn filter lights by carpet shop not working (fixed now) and asked for yellow no entry box at lights as you approach Mill Street as cars are misjudging and then blocking motorist from their journey via Gorwydd Road into Ffordd Beck. Request sent to highways team for consideration. ... Escalated for a reply ongoing
- 7. Near Glanmorfa large trees on main road ongoing.

- 8. Trip Hazard opposite Doctors Surgery tree roots pushing up pavement and its uneven. Reported no response to date. Escalate and awaiting action, advised original email to deal went to wrong email address by a temporary member of staff at the time. ongoing
- 9. Near miss- branch fell off a tree opposite doctors' surgery asked for risk assessment and to cut back branches ongoing.
- 10. Cycle track issues along Oakwood Drive can't see the paint in road- asked for a re- paint. Ongoing
- 11. Speeding Cyclist on track ongoing and have escalated.
- 12. Safer entrance to Oakwood Road shared cycle track / ongoing will take months to sort this one officers have been on leave, ongoing.
- 13. Report of speeding and illegal parking by lollipop lady Rhian in Ffordd Beck, attended site twice and no evidence of this.
- 14. Surgery liaising for if anyone can't ring in morning for appointment and have no access to report online. Person who brought the issue up, has sadly passed away 14. Gowerton park in Park Road, been approached by residents on and off line asking for improvements- trying to get external funding, but will be using my community budget if not to upgrade. ongoing.
- 15. Apple Trees requested by resident If possible, will be planting some apple trees if area is suitable, Liaising with officer in charge.
- 16. Weeds in Church Street reported.
